Termination Hearing

A termination hearing for was held for certified employee Tori Caudell. Superintendent Cline was given 15 minutes to present on behalf of the district explaining Ms. Caudell's refusal to abide by the mask mandate. Ms. Caudell was given 15 minutes to present, she explained she is exercising her constitutional right to medical sovereignty over her body. Superintendent Cline and Ms. Caudell were each given five minutes for rebuttal.

*Vice Chair Summers moved to disapprove the termination of Ms. Caudell. Director Lopez seconded the motion. Motion carried, 4-1. Director Goodrich voted no.*

AP Geography, Medical Terminology, and Anatomy and Physiology Textbooks

David Burke explained that one of Redmond School District's strategic actions in creating ready graduates is to grow Advanced Placement and Career and Technical Education course offerings while increasing student enrollment within advanced courses across our high schools.

This year we are adding three new courses: AP Human Geography, Medical Terminology and Anatomy and Physiology. Typically we adopt advanced placement and career and technical education materials alongside our larger adoption cycles that happen in the spring. However, because we have three new courses within the AP and CTE sequence, we are running a process this fall to ensure our teachers have

the books they need for these new courses. In the future, all adoption processes, including processes for new courses, will run in the spring so that materials can be purchased over the summer and be in place by the start of the school year. This short, off-cycle adoption of three textbooks is simply a result of our desire to innovate within our course offerings and support our teachers with the materials they need. While this adoption process is progressing, the teachers teaching these three courses have been approved to use supplemental materials until textbooks are purchased.

Copies of the books have been ordered for public viewing and will be made available to parents and the broader community in the coming week. Public input will be documented. Once materials are adopted by the board in an upcoming meeting, the district team will make the final purchase.

#### Right-of-Way Dedication – Tony Pupo

Pahlisch Homes currently owns the property directly north to property owned by the Redmond School District directly west of Ridgeview High School. Pahlisch Homes intends to develop the property into a single-family home community. Development of the subdivision will require the extension of SW Coyote Avenue to the west. In order to move forward with the preferred alignment of SW Coyote Ave, right-of way (ROW) is required from the Redmond School District at the NW property line just south of the Pahlisch Property. If the ROW is dedicated from the school district, SW Coyote Ave will be a 60-foot ROW as required by the City of Redmond. If the ROW is not dedicated, Pahlisch will design SW Coyote Ave to have a 40-foot ROW solely on Pahlisch property which will need to be extended to a 60-foot ROW if the school district property develops in the future. The dedication area equates to approximately 20,559 square feet. In exchange for the ROW dedication from Redmond School District, Pahlisch proposes to improve SW Coyote Ave through sidewalk, allowing the school district to only develop the planter strip at the time of future development. Pahlisch will also compensate the school district at the appraised value of \$80,000 per acre which equates to \$37,800 for the 20,559 square feet of dedicated area.

*Director Lopez moved that the Board approve the dedication of a right-of-way of approximately 20,599 square feet for the alignment of the SW Coyote Ave, at the NW property line just south of the Pahlisch property for development of the ROW and compensation to the district in the amount of \$37,800, as well as the sidewalk and planter strip area. Director Cummings seconded the motion. Motion carried, 5-0.*

#### Consent Agenda
